



## Welcome to Henny Penny Farm Camp!

### We are so excited to have the children with us this spring.

Here's our **Farm Camper Checklist**, which includes everything you need to please bring with you and those few things that we kindly ask you do at home before you arrive:

- **RUCKSACK**: Children will carry their backpack between the 2-3 different camp bases each day, so please only bring **one** Rucksack or bag with them. It should fit all the items they will be wearing/bringing to camp with them, including but not limited to:
  - **WATER**: bring a full water bottled labelled with the child's name, we provide re-fills.
  - **LUNCH**: please bring a ***NUT FREE*** packed lunch (with ice pack if required) labelled with the child's name.
  - **CLOTHING**:
    - a hat for sun protection
    - closed toe shoes (absolutely no open-toed shoes allowed); In Spring we wear rubber boots everyday for our camp activities.
    - pack a raincoat if the forecast looks like rain!
  - **FACE MASK**: is at your discretion. If you would like your child to wear a mask at any time, please let us know at drop-off.
- **SUNSCREEN**: arrive with sunscreen already applied (we strive for minimal direct sun so we will not need to re-apply sunscreen).
- **INSECT REPELLENT**: if required, arrive with insect repellent already applied.
- **HANDWASHING**: Please make sure your child is clear about what 20 seconds of hand washing is (sing Happy Birthday twice or whatever is a useful tool for them).
- **HAND SANITIZER**: we will supply hand sanitizer for use throughout the day when soap and water is not available.
- **SNACK**: we will have pre-packaged snacks. ***If your child has allergies or you have any concerns, please supply your own nut free snack.***
- **MOBILE PHONES**: please explain to your child that we operate an 'unplugged' camp experience, so during camp hours phones may not be out and should be switched off or set to silent mode so as not to cause a disruption.
- **WHEN YOU GET HOME**: please make sure your child does a Tick check and takes a shower. This should be done every day after camp as a precaution against Lyme disease.



## **DROP-OFF:**

Due to limited space on our driveway, we have staggered drop-off times based on camp groups, to ensure safe arrival of the children to camp.

Your designated time is stated in the email this document was sent with.

When you arrive for drop-off, please bring your child to the check-in area which will be near the driveway. Once checked in your child will bring their belongings to their designated spot for the day. Please do not leave until your child(ren) have been fully checked in.

## **PICK-UP:**

For pick-up, we also have staggered times based on camp groups, to ensure safe departure of the children from camp.

Your designated pick-up time is stated in the email this document was sent with.

Please come to the same area as drop-off and wait on/by the patio area, your child will be brought out to you.

We don't recommend early pick-up, however, if for some reason it is required, please let us know the details at drop-off.

## **SEVERE WEATHER:**

Since we are mainly outside, if we have a severe thunder/lightning storm roll through we will call you to come collect your child. As our spring camps finish by 12:30pm, we are optimistic this will not be an issue.

## **ILLNESS:**

If your child is showing any signs of a cold, nasal infection or any other illness in the morning, please keep your child home for the day and do not bring to camp. If a child is sent to camp and visibly suffering from an infection or illness, the parents will be called to come and collect them. Please also see the terms and conditions section on the next page for further guidelines.

## Henny Penny Farm Camp Terms and Conditions

### Our day camps happen rain or shine!

We are a working farm and as such, the land and animals need caring for regardless of the weather. In order for the children to gain a true farm experience we embrace all the elements!

### Entering the Farm,

**Welcome!** By entering our farm you are affirming that;

- You and your child do not have a temperature above 100.4 F
- You and your child feel well and do not have any signs of illness

### Behavior on the farm.

Our farm is a safe and enjoyable environment for all everyone. And as such, we have a zero tolerance policy on physical aggression by anyone towards, including but not limited to, people, animals and property.

#### *Program specific behavior:*

In addition to the above, we also do not tolerate repeated disruptive behavior. If after several corrections by our staff or volunteers, we reserve the right to terminate the offending participant's attendance to the program at any time.

If applicable, parents will be notified, and a conversation held to determine if the child can continue to participate in the program.

Should it be decided that attendance will be terminated, the registration fees will not be refunded and we reserve the right to refuse future program registration submissions for that person.

### Farm Camp Refund / Cancellation Policy.

In the unfortunate event that your child can no longer attend camp,

- If their spot can be filled by someone on the waitlist, we will refund your registration fee paid, less 20% to cover credit card processing fees and admin costs, via original payment method.



## **Farm Camp Refund / Cancellation Policy... (cont.)**

- If the spot is not filled from our waitlist, no refund or credit will be issued, as per the original event listing.

You may however, transfer the place to another child who is within the age group of the camp selected. Henny Penny Farm is not involved in this process, so you need to notify us of all the details once the transfer has been arranged.

No changes, transfers or refunds can be made within one week of your camp start date.

In the event we must close the farm due to causes beyond our control, including but not limited to: extreme weather, fire, pandemic, or government action, no refunds or credits will be issued.
